- 551.071 Private consultation with the Board's attorney
 - 551.072 Discussing the purchase, exchange, lease, or value of real property
 - 551.073 Discussing negotiated contracts for the prospective gifts or donations
 - 551.074 Discussing personnel or to hear complaints against personnel or public officer
 - 551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices
 - 551.082 Considering discipline of a public school child or complaint or charge against personnel.
 - 551.0821 Discussing personally identifiable information about public school students
 - 551.084 Excluding witnesses from a hearing
 - 551.087 and TEC 39.030 Discuss the offer of a financial or other incentive to a business prospect
 - 551.088 Deliberation regarding test items
- Should any final action, final decision, or final vote be required in the opinion of the School Board with

regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
