Summary:

Board policy EEB (Legal) requires districts to maintain a class size of no more than 22 students per class in grades K-4. This policy also allows a district to submit an exception waiver to the Texas Education Agency if it is anticipated that class sizes may exceed this limit. In our effort to allow parents to choose both virtual and in-person instruction at multiple times throughout the school year, we are seeking Board for approval to submit the class size exception waiver during the 2020-2021 school year when class sizes in grades K-4 exceed 22 students.

5.9 Additional Days School Year Grant Technical Assistant Consultant

Action

Summary:

The Additional Days School Year (ADSY) Planning Program will support districts intending to implement a full year redesign by adding additional instructional days to their academic calendar.

CISD was selected in the competitive application process and will undergo a year-long planning process to plan for ADSY implementation, which will include the designation of a project manager and access to technical assistance vendors to assist with Design & Implementation, Finance & Operations, and Academics Components. Following the planning year, districts will have a three-year execution phase. The purpose of the Execution Phase is to provide continuous support to districts so they can effectively monitor program performance, improve programs based on learnings, and ultimately improve outcomes for participating students.

As part of the ADSY grant award from TEA, districts are required to select technical assistance to help develop the framework during the planning year of the grant. CISD would like to select Engage2learn to be our TEA approved vendor to help facilitate this work. Engage2leaen has worked with Crowley ISD in facilitating the Strategic Design Work - Vision 2025 and then as Crowley ISD's TEA matched partner for BLGP where we facilitated the

design of a learning framework for blended learning. Attached is the E2L planning proposal for the ADSY Phase 1 implementation.

Budgetary Impact:

\$89,680 to be covered by the grant funds.

5.10 Modification to the 2020-2021 School Calendar to make November 3-4, 2020 Virtual Learning Days Due to Use of School Buildings by Tarrant Count Elections

Action

Summary:

The administration will discuss a possible modification to the 2020-21 school calendar due to the national, state and local elections that will be held on Tuesday, Nov. 3, 2020.

Tarrant County Elections utilizes district school buildings on election day and is expected to need additional space this year due to an anticipated increase in voter turnout and to accommodate for social distancing requirements during the COVID-19 pandemic.

To ensure the health and safety of students and staff, the district is considering possibly making Tuesday, Nov. 3 and Wednesday, Nov. 4 virtual learning days for all students. If approved, this would allow for additional space in school buildings on election day, and would allow the district to clean and sanitize school buildings on Wednesday, Nov. 4 before students return on Thursday, Nov. 5.

5.11 Upgrade of Internet Hotspot Devices for Virtual Learning

Action

Summary:

To adequately support the Crowley ISD students in today's virtual learning environment, the district conducted a review of performance data for the original 1,000 (2G) internet hotspots. It is recommended that the district upgrade the 1,000 hotspots from the \$10 data plan to the \$20 unlimited high-speed data plan.

Once the upgrade is completed, the district's cost for these 1,000 hotspots will increase to \$20,000 monthly which will require an increase of \$80,000 above the planned expenditure of \$162,000. This will bring the total 12-month cost for these 1,000 hotspots to approximately \$243,480.59.

With the proposed upgrades to the existing 1,000 hotspots, Crowley ISD will be able to provide 2,500 students with mobile unlimited high-speed internet connectivity that will better support them in today's virtual learning environment.

Budgetary Impact:

Not to exceed \$80,000 above the planned expenditure of \$162,000

6.1 Chisholm Trail Education Foundation Donation of Innovative Teaching Grants and Virtual Learning Grant

Action

Summary:

Each year, the Chisholm Trail Education Foundation (CTEF) awards Innovative Teaching Grants to Crowley ISD educators. This year, the CTEF is awarding 16 different grants totaling approximately \$31,000:

- \$2,498.29 to the Panther Emporium at North Crowley High School
- \$1,500.00 to the CISD Special Education Dance
- \$4,996 to the Ram Emporium at Allie Middle School
- \$2,000 to the Making Connections: Disability Resources Fair
- \$1,500 to the CISD Elementary Battle of the Books
- \$1,024.95 to the Building our Future with First Lego League Robotics at Mary Harris Elementary School
- \$884.06 to the Box of Facts Math Fun in a Flash at Jackie Carden Elementary School
- \$3,000 to the High School Writing Center
- \$259.45 to help students with autism at June W. Davis Elementary when their surrounding environments become overstimulating
- \$1,000 to the Adult Transition Meal Preparation Training program at North Crowley Highs

- \$1,069.71 to the Crowley 9th Grade Zen Den
- \$5,000 to the Coding/Stem Cub at David L. Walker Elementary School
- \$2,000 to the Guardians of the Garden at Oakmont Elementary Outdoor Classroom
- \$1,500 to CLAWS (Creating Leaders to Achieve World Success) for boys and REGLA Rams (Responsible Educated Girls with Academic Leadership) at Richard Allie Middle School
- \$2,000 to Seeing Myself on the Cover for middle school ELAR teachers across CISD
- \$500 to Linguascope for LOTE at North Crowley High School

In addition to these Innovative Teaching Grants, the CTEF has received a grant from Lockheed Martin in the amount of \$10,000 to support virtual learning in Crowley ISD during school closures during the COVID-19 pandemic.

The Chisholm Trail Education Foundation is a 501(c)(3) non-profit organization that was created to provide a source of funding to the educators and students of Crowley ISD for projects and activities that go beyond the normal classroom experience. The Foundation consists of a volunteer Board of Directors made up of business, community and educational leaders.

 $6.2\,$ Guaranteed Maximum Price (GMP) for the Crowley ISD Sports Complex Earthwork Package

Action

Summary:

Bids for the earthwork package of the new Crowley ISD Sports Complex were received on Sept. 17, 2020. This package will include earthwork and soil stabilization work to allow the start of mass grading on the site. The work will take a minimum of three months to grade and soil stabilize the site in preparation for the building package.

The GMP for the building package is scheduled for the December Board meeting.

Budgetary Impact:

The Guaranteed Maximum Price (GMP) for the earthwork package will be \$2,920,542.
